**(Summary Translation)**

The 2024 Annual General Shareholders' Meeting (the "Meeting") of ECOVE ENVIRONMENT CORPORATION (the "Company") will be held at Mellow Fields Hotel 502 Room (No. 127, Sec.7, Zhongshan N. Rd., Shilin Dist., Taipei City, Taiwan) at 9:00 a.m., Monday, May 27, 2024.

A. The agenda for the Meeting are as follows:

B. The major items of the proposal for distribution of 2023 earnings ratified at the meeting of the Board of Directors are as follows:

- (1) It is proposed to allocate shareholders' cash dividends NT\$1,045,306,890 (based on 71,654,206 outstanding shares at January 31, 2024, Approximately NT\$14.59 per share). After being approved at the Meeting, the cash dividends to common share holders will be distributed on a record date to be determined by the Chairman.
  - (2) Should the total common shares outstanding change for any reason, the ultimate cash dividend to be distributed to each common share may need to be adjusted accordingly. It is proposed that the Chairman of the Company will be authorized to adjust the cash to be distributed to each common share.
